SURFACE PREPARATION

Remove all loose and flaking paint, wire brush surfaces to remove any contamination and loose materials which are unsound in depth. Any algae or mould must first be removed by mechanical means or with Thompson's Mould and Mildew Cleaner.

APPLICATION

This is a ready to use product. DO NOT DILUTE. Apply by brush, airless spray or roller in one liberal coat. For extremely porous surfaces, apply a second coat when dry. Drying time 2-4 hours depending on temperature, humidity etc.

Previously painted work may be painted as part of the process but care must be taken to ensure meticulous preparation to avoid "edge lifting". Work painted with gloss coating should not be stabilised with this product.

COVERAGE

 $5\text{-}10\text{m}^2$ per Litre depending on porosity of surface and method of application.

CLEANING

Clean equipment with soap and water after use.
